The Company must process personal data so that it can provide these services – in doing so, the Company acts as a data controller.

1. COLLECTION AND USE OF PERSONAL DATA THROUGH THE WEBSITE

1.2. COOKIES

We may obtain data about you from cookies. These are small text files that are placed on your computer by websites that you visit. They are widely used in order to make websites work, or work more efficiently, as well as to provide information to the owners of the site. Google sets a number of cookies on any page that includes a Google Maps. They store simple data to measure the number and behaviour of Google Maps users without storing any personal information.

1.3. LOG FILES

We use IP addresses to analyse trends, administer the site, track users' movements, and to gather broad demographic information for aggregate use. IP addresses are not linked to personally identifiable information.

2. OVERSEAS TRANSFERS
